- I. **Treasure's Report** (Linda Jones)
  - a. Current balance: \$3.7K
  - b. Revenues due in from Country Run and concessions
  - c. Banquet and scholarships coming up
- II. Update on Track Meets (Coach Christensen)
  - a. District meet: Monday, 4/11 & Wednesday, 4/13 (no meet on Tuesday)
    - i. Prelims on Monday (all day); Finals on Wednesday;
    - ii. Monday:
      - Field events start at 9am;
      - Running prelims start at 2:30
      - 2 mile starts ~4ish (final race)
    - iii. Wednesday:
      - Meet events will start at 5pm (Running)
  - b. Regional meet: May 2<sup>nd</sup> & 3<sup>rd</sup> @ Texas A&M Commerce
- III. **Scholarship**
  - a. What's different – Seniors attending D1 or D2 schools will NOT receive any track booster club scholarships because it will be deducted from their collegiate scholarship;
  - b. Scholarship amount: \$500/athlete in track or cross-country (only one scholarship/athlete)
  - c. Information on the process to be used to determine scholarship recipients will be sent out this week (4/4)
  - d. Deadline to apply will be established later in April
  - e. Scholarships will be awarded in May

- f. An unbiased committee (2 – 3 people) will be asked to review candidates and determine scholarships

- iii. Election process changes made at LLI which will be replicated throughout all booster clubs:
  - Officer nomination will be a slate of candidates proposed by a nominating committee
  - General public booster club must have the opportunity to nominate candidates from the floor on the day of the elections
  - New officers must be in place prior to May LLI compliance meeting
  - Candidates must have a student athlete in the program
  - Term in office is 1 year, with the option to be re-elected for a second term; Max terms in the same office is two years; A candidate could run for a different position;
  - Husband and wife cannot hold offices in same club
  - Elections will be held on May 3<sup>rd</sup> at next track booster club meeting
