## Discussion

## 1. Call to Order

Bob Brands called the booster meeting to order at 7:06 pm.

## 2. Review Minutes from Last BC Meeting

Flora Brands sent out the minutes after the February meeting and Kim Tedford sent out minutes prior to this meeting for approval. Kim Tedford motioned to approved minutes and David Myers seconded the motion - minutes were approved.

## 3. Treasurer Report

Libby Hartter updated the group on the budget to date (see attached). Budget is healthy at \$15,100. We have a few invoices and anticipating a few expenses that amount to about \$8,000. They include \$1600 for track tshirts, \$591.05 for banners, approx. \$1,500 for upcoming Texas Relays(3-4 athletes) and \$5,400 for sweats for the team. Libby suggested that we keep at least \$5,000 in reserves over the summer to cover the XC & Track scholarships and carry over forward to fall. *The booster voted on spending the \$591.05 for the banners: Bob Brands motioned to approve and Betsy Bittner seconded the motion – all approved the expense. The booster also voted to spend \$5,400 on 60 sets of warm ups for the teams: Bob Brands motioned to approve and David Myers seconded the motion – all approved the expense.* 

## 4. Membership Report

Flora Brands reported that we continue to receive membership forms amounting to \$6,600 and 80 families currently. Bob Brands asked all to bring ideas on how to get more Middle School participation in membership: HS kids sharing at prescheduling making meetings, showing
